<u>15/147. MINUTES OF THE PARISH COUNCIL MEETING HELD ON – Tuesday</u> <u>15th December 2015</u>

The Minutes of the Parish Council Meeting held on Tuesday 15th December 2015 (pages (1100 - 1108) having been approved, were adopted and signed as a true and correct record subject to the following amendment:

15/148. MATTERS ARISING FROM THE MINUTES

a. There were no matters arising to report.

15/149. COUNTY COUNCILLOR'S REPORT

There was no report.

15/150. DISTRICT COUNCILLOR'S REPORT Clir Mr S. S. Tong

a. <u>Annual Financial Settlement:</u> The annual rate support grant will be tapered off over a period of years, eventually diminishing to zero. All Local Government Taxes will have to be raised locally. 15 authorities including East Dorset District Council have been earmarked to lose their support grant in 2017/2018. The remainder will lose them in 2019/2020. The District Council has not budgeted for such a steep cut – off. The Community Charge (Council

Tax) has been capped for the last eight years and the Non Domestic Tariff (Business Rate) is paid to the National Government which then redistributes the tax to local authorities. County Councils and other Unitary Authorities will be allowed to add 2% to their budget to help with the provision of Adult Social Care, this amount will only cover about a third of the Adult Social Care budget.. Overall the Council Tax will go up by 4% (2% from the County Council and 1.9% from the District Council). Regarding the Business Rate, the Government has not decided how to reorganise the distribution and how much of it District Councils will be allowed to keep. The pressure is now bearing down on local authorities to consider how they might re-organise in order to reduce running costs.

b. <u>Revised Governance Proposals</u>: The nine Dorset Authorities have been considering four proposals, A unitary Authority, a Combined Authority, A South East Dorset Unitary Authority and the Status – quo. Eight of the authorities have agreed to fund an in depth business study of each proposal so that the authorities have the necessary facts and projections to make a well considered decision. East Dorset District Council voted against funding the business study which leaves the District Council out of step with the rest of the County. Cllr Mr S. S. Tong is acting as temporary leader of the council until a new leader is elected next month.

15/151. PARISH CLERK'S REPORT

a. Flood Alleviation:

- i. **Witchampton:** There have been no incidents of flooding but the promised annual monitoring does not seem to have been carried out. The flood warning signs and visibility jackets are ready in case of flooding.
- ii. **Gussage All Saints:** The flood warning signs are ready should there be any flooding. The road past Amen Cottage has a steep camber and runoff crosses the road at this point and is diverted down the high street. There used to be a drain through the garden of Walnut Tree Cottage that diverted this run-off down to the river. This drain seems to be blocked and the run-off is reaching properties further down the High Street with a threat of possible flooding.
- iii. <u>Hinton Martell:</u> The cleared drains seem to be working well and there have not been any problems. The drainage pipe outside St Christopher's is damaged and needs repair and cleaning. Mr Alan Butcher has a drain cover at the side of the road outside his property. He cleans the silt from the pipe as best he can as it takes the run-off through his property to the stream, but it now needs to be power blasted through to clear it. The drains on Uppington Hill, opposite the Dell are full of gravel and need clearing.
- b. Witchampton Telephone Kiosk: It was considered that the main problem could be alleviated by moving the dog waste bin to the other side of the bus shelter. The Clerk was asked to contact the Highways Department to ask their advice about how to best re-enforce the edge of the highway abutting the verge.
- c. **Hinton Martell Notice Board**: The notice board is complete and Cllr Ms D. White will contact Mr H. Giles to arrange for the installation outside the Village Hall. It was noted that the Gaunts Common notice board was in need of refurbishment. The Clerk was asked to contact Mrs Lisa Goodwin, Clerk to Holt Parish Council for permission to go ahead with the refurbishment.
- d. **Website:** Cllr Mrs P. Hill and Cllr Mr S. Wathen reported that they had written a short description of their area and included some photographs for posting on the web site.

- e. **Rest & be Thankful Seat:** It was reported that in February, the proceeds from the regular lunch meeting in the Witchampton Village Hall will be donated to the Fingerposts Fund. It was suggested that a similar fundraising could be used to support the Rest & be Thankful Seat later in the year. It was also suggested that a letter could be delivered to all local residents asking for financial support for the replacement of the seat..
- **f. CIIr Mr S. Butler:** Cllr Mr S. Butler had sent a short e-mail listing his help with the flood alleviation efforts and help with funding various projects in the Vale of Allen. The Council expressed its thanks for his help.
