## 15/101. PUBLIC QUESTION TIME

- a. Mrs Jackie Wharfe, Chairman of the Hinton Martell Village Hall Management Committee gave a short presentation explaining the Committee's plans for refurbishment and upgrading the facilities at the Hinton Martell Village Hall. The intention is to create a hub to support the local community and to promote community activities. Plans have been drawn up and support funding for the planning stage of the project is being sought from the District and County Councils as well as other sources.
- b. Mr Adrian Morris: Honeysuckle Cottage, Moor Crichel. Mr Morris explained his intentions regarding the application to add an extension to this very tiny cottage and answered Councillor's questions regarding some details of the application.
