18.041. COUNTY COUNCILLOR'S REPORT

Cllr Mr S. Butler delivered a power point presentation bringing the Parish Council up to date with the progress of the Local Government Re-organisation. Interim officers and cabinet members have been appointed to the Shadow Authority.

18.042. DISTRICT COUNCILLOR'S REPORT

18.043 PARISH CLERK'S REPORT

a. Update on the Appointment of a New Clerk: The Appointment Panel offered the job to Mr Ian Hanstead from Gussage St Michael and the job has been accepted. As Mr Hanstead does not have previous experience as a clerk there will be a two month handover period to get Mr Hanstead familiar with Parish Council procedures.

- **b. Dorset Area Joint Committee:** County Councillor Mr S. Butler gave members a detailed update on the creation of an Interim Shadow Authority.
- c. Local Government Boundary Commission: The LGBC held a briefing session on the electoral review of wards in the two new unitary councils. The briefing was attended by the Parish Clerk and Mr Ian Hanstead. A draft proposal for public consultation is being drawn up and will be published on 3rd July 2018. The LGBC is requesting that consultees; as well as informing the commission of any objections to the proposals also indicate those parts of the draft that meet with their approval.
- d. General Data Protection Regulations: The National Association of Local Councils has drawn up a model policy document for Councils to customise to their own needs. Councillors were issued with copies of the draft which will be discussed in more detail at the next Parish Council meeting.
- e. Dorset Steam Fair: The pre-event meeting on 14th June 2018 was attended by the Parish Clerk. It is the 50th anniversary of the Steam Fair and the organisers want to attract at least 500 steam engines in an attempt to get into the Guinness Book of Records. At the meeting the Clerk stressed the need to keep the arrangements for a temporary Gypsy camping site in place even if it was only lightly used. The County Council gave assurances that the site would remain as an essential part of the arrangements
- f. Community Service Certificate: Cllr Mr S. Wathen reported that a young person, under the supervision of an adult, had helped in the refurbishment of the fingerpost at Horseshoe Cross, Hinton Martell. There must be other events that involve the help and engagement of young people and Cllr Wathen suggested that awarding a Community Service Certificate would be a way of encouraging youngsters to carry out work that helps the community.
