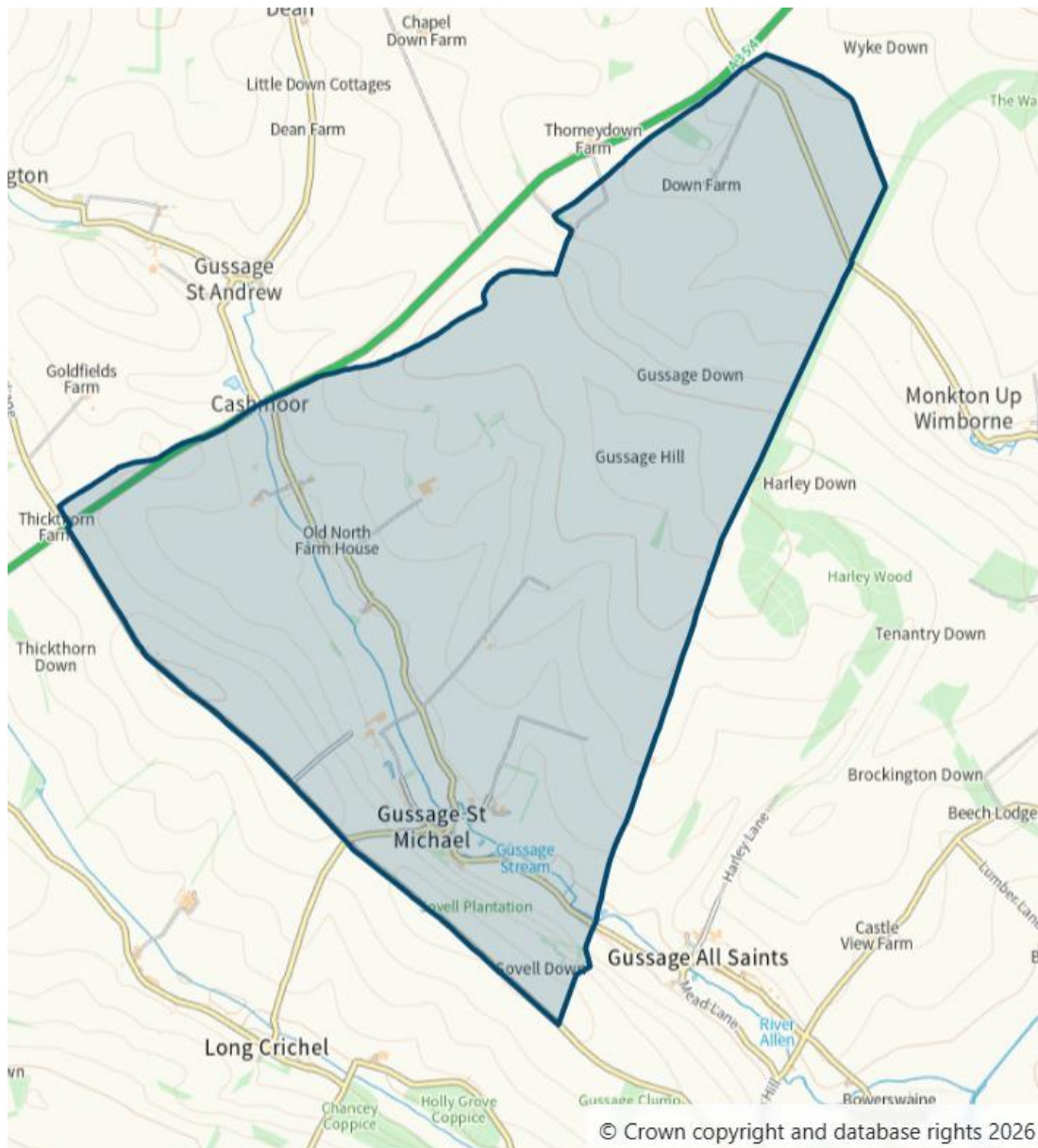

Context and Purpose

The government introduced a Localism Act in 2011 to give residents more say in the development of their own parish. A key part of this is the development of a Neighbourhood Plan by the local community and the Parish Council. The Plan will have legal status and will be used to influence future planning decisions affecting the Parish.

The Parish Council has set up a committee of representatives from each village within the Parish to develop the Plan, which will take 12-18 months to produce and agree with Dorset Council. There will be many opportunities for residents to air their views in that time, but the first step is to obtain up to date information about each of our village communities. Hence this questionnaire.

There will be a single Vale of Allen Plan, but we are gathering information from each of the communities within the Parish, so the questionnaire has been tailored to each village’s features and facilities.

- What makes living here special?
- How do you use village facilities and infrastructure, and what changes would you like to see?
- What are your views on housing, development and the environment?
